ADTC Release of Liability & Assumption of Risk Agreement

I hereby release American School of Dance, LLC (dba: American Dance Training Camps – “ADTC”), its officers, employees, contractors, and agents from any and all liability, claims, demands, or causes of action which may occur by reason of injury, loss, or damage sustained by me during participation in camp activities.

I understand that activities at ADTC may involve vigorous physical movement, physical contact, and exposure to environmental conditions. I acknowledge that injuries may occur, including but not limited to strains, sprains, fractures, illness, or more serious conditions.

DANCE: Participation in dance activities carries inherent risks. I confirm that I understand these risks and voluntarily choose to participate.

OPTIONAL ACTIVITIES: I understand that recreational and off-campus activities may be offered. I may be expected to participate in and/or supervise activities as part of my role.

ACTIVITY RELEASE & AGREEMENT: I assume full responsibility for my participation and agree to follow all camp policies and instructions. I will immediately remove myself from participation and notify staff if I observe unsafe conditions.

HEALTH HISTORY & INSURANCE: I certify that my submitted health information is accurate. I confirm that I have appropriate health insurance coverage and understand that I am responsible for any medical expenses incurred.

MEDIA RELEASE: I grant permission for ADTC to capture and use photographs, video recordings, audio recordings, and other media of me during camp. This may include dance classes, choreography, performances, and other activities. I authorize ADTC to use this media for marketing, advertising, social media, website content, and educational purposes, in perpetuity and without limitation, without additional compensation. I understand that this media may be publicly accessible and I waive any right to inspect or approve its use.

COMMUNICABLE ILLNESS: Participation in camp includes potential exposure to communicable illnesses (including, but not limited to, COVID-19, influenza, and other contagious conditions). While ADTC takes reasonable precautions, exposure may still occur. I voluntarily assume all related risks.

CANCELLATION BY ADTC: ADTC reserves the right to cancel any camp session. ADTC is not responsible for non-refundable travel, lodging, and personal expenses.

INDEMNIFICATION: I accept full financial responsibility for any injury or damage resulting from my actions and agree to indemnify and hold harmless ADTC and associated parties.

I understand that I am engaged as an independent contractor and not an employee of ADTC.
